6. The credit line must appear in the caption or list of credits for each reproduction.
7. Rights to reproduce/display are non-exclusive and are granted for the one-time use or uses as detailed on the application form. Any further revisions, editions, formats, or uses require a new application to be submitted and a fee to be paid, if applicable.
